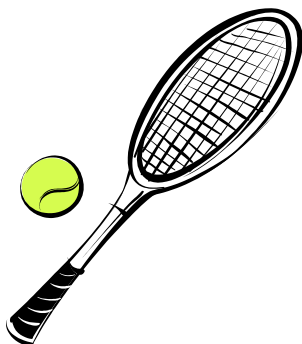

As a facility of the Boys & Girls Club of Southwestern Oregon (BGC), the William J. Sweet Memorial Tennis Center is available to support the growth of tennis on the South Coast. This includes lessons for all ages and abilities, ongoing adult mixers and drills, opportunities for youth in the after school program, availability for local high school teams practices and competitions, as well as open court reservations.

Kylee Woodman has 18 years of tennis playing experience. She played for North Bend High School, competing at #1 singles all four years. She also played for Slippery Rock University in Pennsylvania where she graduated with a Bachelors of Science in Exercise Science. She has taught players of all ages, from the beginner to advanced. ## Fees & Rates

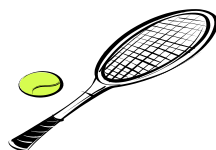
There are three levels to choose from. Participation in Level 1 or 2 is for those who will be using the courts more often. Level 3 is for the occasional user.

Those signing up for Level 1 must pay the fee in full by January 1st.

Those choosing Level 2 must make monthly payments by the first of the month for the remainder of the calendar year. Court reservations will not be accepted until the fee is paid.

A “start up” processing fee of \$100 is due for both Levels 1 & 2. A Saturday court use fee of \$10/court/hour must be paid by all levels.

Those opting for Level 3 will pay a per use fee which must be paid prior to accessing the courts.



### Level 1/Level 2

Junior **\$540/\$50** (“start up” processing fee waived)

- Up through age 18
- Annual BGC membership form must be completed and submitted with an additional \$15 fee

Individual **\$756/\$70**

- Age 19-64

Couple **\$1026/\$95**

- Age 25-64

### **\$100 “start up” processing fee for categories over age 18**

#### Level 1/Level 2 continued

Family **\$1,188/\$110**

- Includes dependent children who qualify to be claimed on the adult’s federal and state tax filing or for whom the adult is paying child support. (A foster child or an exchange high school student may also be included.)
- An annual BGC membership form must be completed for all children up through age 18 and submitted with an additional \$15 fee per child.

Senior Individual **\$702/\$65**

- Age 65+

Senior Couple **\$918/\$85**

- Both must be 65+

Military Individual **\$648/\$60**

- Active Duty

Military Family **\$1,080/\$100**

- Active Duty
- Includes dependent children who qualify to be claimed on the adult’s federal and state tax filing or for whom the adult is paying child support. (A foster child or an exchange high school student may also be included.)
- An annual BGC membership form must be completed and submitted for all children up through age 18. (\$15 fee is waived.)
